

Copyright Transfer Agreement for the *China Journal of General Surgery*

All authors of the aforementioned paper agree to transfer the copyright of this article to the Editorial Department of the *China Journal of General Surgery (CJGS)* free of charge, and agree to the journal's open access policy. The specific details regarding these matters are clarified as follows:

1. The authors of the paper agree that once the paper is accepted, the Editorial Department of the *CJGS* will hold the copyright to all or part of the content of this article, including but not limited to the rights of reproduction, distribution, compilation, translation, information network dissemination, performance, and adaptation, in both print and electronic formats. The authors still retain their moral rights to the work. The Editorial Department has the right to permit domestic and international literature retrieval systems, network and database systems to retrieve and include the article; and has the right to publish and use the article in various media, languages, and formats, in a manner that does not violate the laws and regulations of the People's Republic of China. Meanwhile, we agree to the journal's open access policy.
2. The authors of the paper guarantee that the paper is an original work and does not involve intellectual property disputes, confidentiality issues, or simultaneous submissions. If any infringement or leakage issues occur, all responsibility will be borne by the authors of the paper.
